#### 24/130 Welcome and Introductions

#### 24/133 Public Session

The member of the public asked Cllr Preece to speak on his behalf regarding harassment he felt he had received when carrying out building work at his property. T&WC planning enforcement have visited the site and determined there is currently no breach in the building planning application whilst the work is being carried out. A T&WC neighbourhood enforcement officer has been contacted and will liaise with the householder and Cllr Preece. The same member of the public has received a complaint letter regarding noise from the T&WC Environmental Team to which he has replied by email three times but has not received a response, Cllr Hannington said she will raise this directly with the officers involved.

# 24/134 Minutes of the Previous Council Meeting

It was **RESOLVED** to approve the minutes of the meeting held on the 15<sup>th</sup> January 2025 as a true record.

# 24/135 Councillors Reports

#### Cllr. I Preece:

- Environmental work following the recent storms, fallen trees, damage to paths etc has increased workload for himself and Cllr. Mehta.
- The land at the Cheshire Cheese has now been tidied and access restored. There is still an issue with an adjoining piece of land under different ownership. This is in hand and TWC are keeping a close eye on the site.
- The recently constructed bridge near to the site has very poor drainage. This has been reported to highways.

#### **CIIr. Rogers:**

- T&WC have stated that broken fencing in Nightingale Walk was on private land and, therefore, not in the Idverde contract. Cllr Rogers advised that it had been on the schedule in the past and the Clerk was asked to double check the information and to obtain a map detailing the contract services undertaken by Idverde in the Parish.
- Cllr Rogers would like to introduce himself to residents. It was agreed that it
  would be appropriate for him to do this. The Chair offered to accompany him if he
  wished.

#### Chair:

- The Chair contacted Dylan Lawson, T&WC Public Transport Officer, regarding the lack of markings for the two bus stops on Castlefields Way. Cllr Hannington advised that there was now funding available for the markings.
- The Parish Council will need to respond to the T&WC community governance review in March. The Clerk will send out information to councillors.
