The Chair welcomed everyone to the meeting and welcomed back Cllr. Rogers

### 24/98 Public Session

One member of the public enquired about the rules of the meeting, this matter was discussed briefly and the member of the public was directed to the Parish Council website where a copy of the Parish Council standing orders, together with all other policies and regulations, are available.

### 24/99 Minutes of the Previous Council Meeting

It was **RESOLVED** to approve the minutes of the meeting held on the 16<sup>th</sup> October 2024 as a true record.

### 24/100 Councillors Reports

### **CIIr. S Wennington:**

Cllr. Wennington's report had been prepared and circulated to Councillors in advance of the meeting. The report provided details of the climate change meeting Cllr. Wennington attended on the 18<sup>th</sup> of October and the CAT Walkabout which she attended on the 12<sup>th</sup> of November.

### CIIr. Preece:

- Had arranged for bollards to be installed on Corbett Close, Little Dawley, to prevent motor vehicles from taking a short cut between the houses
- Reported that the recent snow fall had been challenging and he had helped grit Jarmen Drive, Horsehay.
- Cllrs. Mehta and Preece had given pride fund awards to the Horsehay Horticultural Society and the Steam Railway Veterans Café. These awards have been match-funded by the Parish Council.

### Cllr. Mehta:

- Reported glass on the play park by Jarmen Drive, Horsehay

### Chair:

- Is concerned that the Aqueduct Surgery has planning permission but that he has been unable to find out who the new tenants are, he is continuing to pursue this matter with T&WC
- Reported that the three parish Christmas trees are in place and will be lit up until January 6<sup>th</sup>
- Attended and laid the wreath at the Little Dawley Remembrance Service on November 10<sup>th</sup> and attended the Aqueduct Remembrance Service later that day where Cllr. Heighway laid the Parish Council wreath
- Attended the CAT Walkabout on November 15th
- Reported that he has inspected the bench on Viscount Avenue, Aqueduct, and notified the local resident who would like to pay towards a replacement that it is not ready for replacement yet but the situation will be re-evaluated in the future
- Was pleased to announce that work is now able to go ahead to prevent the path at the end of South View Road from continually flooding thanks to a £1,500 Pride Fund contribution from each of the Borough Councillors, Andy Burford and Lyndsey Parker which will be match funded by the Parish Council. The Safer and Stronger Team will fund the remainder of the cost which is estimated at around £4,000.

### 24/101 Community Action Team (CAT)

- a) The Council discussed the CAT Walkabout session held on Friday 15<sup>th</sup> November which was attended by the Chair and Cllr. S Wennington.
- b) The updated action plan for October 2024 and a new action plan for November 2024 were circulated to Councillors in advance of the meeting and the contents were noted. Borough Councillor Burford said he was currently pursuing residents parking signs for Aqueduct residents.

### 24/102 Local Nature Reserves (LNRs) in the Parish

A report from Angela Porteous, secretary for the FoHP&E, was received and circulated to Councillors in advance of the meeting. The contents of the report were discussed and noted.

The Chair reported on behalf of the Friends of DHLNR:

- The Friends of DHLNR committee members are attending various training courses
- The Friends group website is currently being updated
- The Buglife project has come to an end
- Richard Shaw, T&WC Environmental Community Liaison Officer, and Southall School have scarified the area between the picnic bench and the old ironworks and seeded it with wildflowers.
